The Coordination of the **Graduate Program in Cardiovascular Sciences** at the Universidade Federal Fluminense, considering what establishes Resolution 121/2000 of the Teaching and Research Council, announces that the enrollment for the MASTER'S program selection process will be open through this Notice, which replaces the previous one.

**1. CONCENTRATION AREA AND ANNUAL VACANCIES**

**Cardiology**

**For Brazilians: 16**

**For foreigners: 1**

**Option for the Affirmative Action policy:** Candidates who have opted for affirmative action policy -- quota of an ethnic and social nature, including mothers of children under 5 (five) years of age or mothers of children with special needs, will have priority in filling the vacancy, in compliance with UFF Ordinance No. 57,719/2017.

Paragraph 1. A weight of 1.27 will be computed on the grade of the project/interview when the candidate who has opted for an affirmative action policy - Quota of an ethnic and social nature - obtains a grade equal to or higher than the minimum for approval (7);

Paragraph 2. In the case of mothers of children up to 5 (five) years of age or mothers of children with special needs, a weight of 1.2 will be computed on the grade of the project/interview;

Paragraph 3. In both cases, in order to prove the right to priority and specific weight arising from an affirmative action policy, candidates must submit an Affirmative Action Statement (Annexes II, III, and IV).

Paragraph 4. The candidate who enters the Master's Program through the ethnic-racial affirmative action policy may be invited at any time to introduce him/herself to the Assessment Committee instituted by UFF, and must sign a Term of Agreement with this possibility at the time of enrollment.

## **2. TARGET AUDIENCE**

Graduates in Medicine, graduates in other careers in the field of Biomedical Sciences or in other areas of interest in Cardiovascular Sciences.

- **PREREQUISITES**

- **Concentration Area in Cardiology:** Present documentary evidence of completion of a bachelor's degree in Medicine at a national or foreign institution recognized by the Ministry of Education.

- **Concentration Area in Biomedical Sciences:** Present documentary evidence of completion of a bachelor's degree in one of the careers in the biomedical field or other areas of interest in cardiovascular sciences, in a national or foreign institution recognized by the Ministry of Education.

**Note:** Study regime - The candidate must have as a study regime, at least, the workload of 20 hours per week, and 1 hour a week individually, with the foreign advisor.

### **3. APPLICATION**

Applications for the selection process will be carried out remotely. Candidates must complete the Application Form (the link will be made available on [www.poscardio.sites.uff.br](http://www.poscardio.sites.uff.br)) and attach to the form all documents listed in Item 4, in high resolution, in PDF, and organized, until 11:59 pm on the date defined in Annex I.

The selection process for the program will be carried out exclusively in online mode. The internet connection and the technical requirements (such as: computer or smartphone, programs and applications, etc.) are the sole responsibility of the candidate.

Upon registration, candidates must authorize the recording and, if applicable, the dissemination of the presentation videos of the preliminary project, as well as the online interview.

#### **3.1. FEE WAIVER FOR ENTRANCE EXAMS FOR THE MASTERS AND DOCTORATE PROGRAMS.**

Exemption from the application fee for the selection exams for the Doctorate Programs in Cardiovascular Sciences may be requested by candidates enrolled in the Single Registry for Social Programs of the Federal Government - CadÚnico, under the terms of the Federal Decree 6,593/08 (or 6,135 of 6/26/2007), and members of a low-income family. Candidates must complete the Application Form for exemption from the Registration Fee (available on [www.poscardio.sites.uff.br](http://www.poscardio.sites.uff.br)) and attach the following documents, until 11:59 pm of the date defined in Annex I: a) Proof of enrollment in the CadÚnico; b) Social Identification Number - NIS, assigned by CadÚnico; c) Declaration that you are a member of a low-income family.

Applicants must present proof of payment of the fee upon registration.

## 4. MANDATORY DOCUMENTATION

Candidates must complete the Application Form (available on [www.poscardio.sites.uff.br](http://www.poscardio.sites.uff.br)) and attach all documents listed in Item 4 to it, in high resolution, in PDF, and organized until 11:59 pm of the date defined in Annex I.

- c) Declaration of completion or diploma of a bachelor's degree program in renown institution;
- d) Lattes *Curriculum* updated, **with proof of titles and all activities described there that are associated with research, extension, teaching activities, publications and scientific events.**
- e) A 3x4 photo;
- f) Proof of payment of the Application fee as specified in item 3;
- g) Preliminary project developed within one of the Research Lines of the Program;

- h) Presentation letter from the advisor, accredited to the Graduate Program in Cardiovascular Sciences at UFF (free format);
- i) Letter of intent from the candidate addressed to the Coordinator of the Graduate Program in Cardiovascular Sciences at UFF (see contents in Annex I);
- j) Declaration of opting for vacancies for Affirmative Action in accordance with Annex II for the blacks, "pardos" (brown-skinned) and indigenous people, and Annex III for people with disabilities in accordance with current legislation. The disabled must attach a medical report with the type and the degree or level of the disability, as well as its probable cause, with express reference to the International Classification of Disease code.
- k) Candidates with disabilities must indicate on the registration form if they need accessibility resources and assistive technology in accordance with the current legislation to carry out the tests and attach a medical report with the type and the degree or level of the disability, as well as its probable cause, with express reference to the International Classification of Disease code.
- l) Applicants who have opted for an affirmative action policy - to prove the right to priority and specific weight arising from an affirmative action policy - Ethnic and social quota - must submit an Affirmative Action Statement (Annexes II, III, and IV).

**Note:** The degrees obtained in foreign universities will be conditioned to Resolution 18/2002 CEP-UFF, which provides for their acceptance for the purposes of continuing studies at UFF.

## **5. RESEARCH LINES AND ADVISORS**

5.2. The advisor must be a professor accredited to the Graduate Program.

## **6. SELECTION PROCESS**

6.1. The selection process will consist of two stages, the first one being eliminatory, consisting of an English test, applied by the Graduate Program or in a third-party way, and the second one consisting of curriculum evaluation (only classificatory) and presentation of preliminary project (eliminatory).

## 6.2. Requirements of this process:

(1) English exam, by sending a Google Forms questionnaire to be filled out by the candidate.

Sole Paragraph: Alternatively to the English test, proof of proficiency in English with the minimum passing grade may be presented at the time of application, EXPEDED IN UP TO 2 (TWO) years. The following certificates will be accepted:

- TOEFL - IBT (0-120) – 36 points
- TOEFL - ITP Level 1 (310-677) – 240 points
- MTELP (0-100) – 30 points
- IELTS (1-9) – 3 points
- FCE by Cambridge – B2
- ECCE – Pass
- ANPAD English Exam (0-600): 222 points
- GMAT® (0-60) – 18 points in the oral session

(2) a video recording of the preliminary project presentation, with a maximum duration of 10 minutes, previously to the examination board (until 23:59 on the date defined in the Notice; guidelines for sending the video will be provided);

(3) online interview through Google Meet by the examination board. If the candidate has difficulty connecting at the time of the interview, a second opportunity will be defined no later than 2 hours after the defined initial time;

## 6.3. Preliminary project:

- Structured preliminary project with a maximum of 20 pages. Sections: Cover - Summary - Introduction - Objectives - Methodology - Incentives - Execution schedule - Perspectives - Bibliographic References - Addendums (forms, consent form, complete PDF with the approval certificate of the research ethics committee)

## **Preliminary project structure**

- Cover: Identification of the candidate, his/her advisor, CNPq areas (<http://lattes.cnpq.br/documents/11871/24930/TabeladeAreasdoConhecimento.pdf/d192ff6b-3e0a-4074-a74d-c280521bd5f7>), title of the project, key-words;
- Structured summary covering a maximum of 400 words: Introduction - Objectives - Methodology - Perspectives.

Note: The presentation of documents outside the required format will result in a discount of 0.5 point from the total score attributed to the interview/presentation of the preliminary project.

#### 6.4. Presentation of the preliminary project:

- Structured (such as item 6.3) in Power Point (.ppt) duration of 10 min max, followed by 10 min of argumentation/interview.

#### 6.5. Candidates will be eliminated if they:

- a) do not attend any of the selection phases or appear after the time established in each phase;
- b) use any type of electronic receiver equipment;
- c) use illicit means to take the tests;
- d) disturb the order of business in any way;
- e) receive a grade lower than 6.0 in the first selection phase (English exam).

Note: The candidate must return all material received at the end of the test.

6.6. Being qualified to go through the second phase of the selection, the minimum grade for interview/project presentation will be 7.0. The final classification among those not eliminated due to insufficient grade will be based on the following weights:

- Curriculum analysis – weight 1
- Interview/presentation and defense of the project – weight 3

6.7. If there are candidates with the same final average, there will be a tiebreaker, which will take into consideration the following criteria:

- 6.7.1. Highest grade in the interview/project presentation and defense;
- 6.7.2. Highest grade in the curriculum;
- 6.7.3. Highest grade in the English exam.

6.8. The use of the vacancies of the Program will follow the decreasing order of the total number of points obtained by the candidate as the final average. If the vacancies



reserved for candidates opting for Affirmative Action are not filled, these will be available for wide competition. There is no obligation to fill all vacancies.

6.9. The examination board is sovereign to, in spite of the final grade, nominate approved candidates to carry out probationary internships, in case the respective projects do not have a positive review by the Research Ethics Committee.

6.10. The allocation of approved and nominated candidates for enrollment in scholarships will be in decreasing order of the final grade, respecting the criteria established by the Scholarship Committee of the Graduate Program in Cardiovascular Sciences. Their unavailability will allow the creation of a valid official waiting list until the next selection process is carried out or until the use of all scholarships that becomes available.

## **7. FINAL DISPOSITIONS**

7.1. Candidates must show an original identity document whenever requested. And in remote mode, they should be available for activities in real time.

7.2. Candidates are responsible for the accuracy of the information provided in the application stage and those who pass this selection must be aware that, according to CAPES Ordinance 13/2006, the theses and dissertations defended in the Graduate Program in Cardiovascular Sciences at UFF will be made available on the CAPES website;

7.3. Applicants must show, whenever requested, the originals of the documents presented by means of copies. Applications with incomplete documentation will not be accepted;

7.4. The results will be widely publicized as it is a public notice;

7.5. There will be no refund of registration fee;

7.6. All cases not covered in this Notice will be resolved by the examination board, upon request for an appeal that must be forwarded according to the selection schedule (see Annex I);

7.7. Masters candidates wishing to apply to the Doctorate program in parallel should consult the corresponding notice, paying particular attention to the eligibility and

evaluation criteria, and stating this intention in the registration form for the Master's selection process.

- Time availability for the program (0.0-0.5 points)
- Approval of the project by the Research Ethics Committee (Up to 1.0 point)
- Experimental design and project feasibility (0.0-3.0 points)
- Clarity in the presentation of the preliminary project (0.0-3.0 points)
- Relevance and Impact of Work (0.0-2.0 points)
- Preliminary data (0.0-0.5 points)
- Internationalization (Up to 1.0 additional point)
